Project details

The project is funded by the DG Justice, under the Rights, Equality and Citizenship Programme 2014-2020. The project's activities started in March 2020 and its duration is 24 months.

5. Dedicated awareness raising activities continue to take place at national and EU level. In Bulgaria, the efforts of Bilitis Resource Center to influence the decision of the Constitutional Court on the interpretation of the term "sex" did not yield the desired outcome. The Court issued its decision on October 26, 2021, and strongly underlined that there is only one possible understanding of the term "sex" according to the Bulgarian Constitution. The court stated that sex is defined as biological characteristics that determine the "reproductive behavior" of the individual. At the same time, the court decision includes a reference to intersex people:

"The Court finds that gender identity can be the basis for changing the sex recorded in civil status records only in the borderline hypothesis in which, due to deviations from the typical combinations of sex chromosomes (XX in women and XY in men), the person possesses sex characteristics distinctive of both sexes and therefore gender identity is not biologically determined (State, which is defined as "intersex"), and therefore such a change would not be contrary to the understanding of gender embedded in the Basic Law, which is based on gender binary." In this way, the Court determines that intersex people have a valid reason to seek legal gender recognition. At the same time, the existence of psychological sex is not recognized in this decision, which implies that the Court does not recognize the existence of legal prerequisites for the gender recognition of trans people. The decision does not entirely block LGR procedures for trans people, but may have negative implications in such cases. The legal uncertainty for LGR cases in Bulgaria will in general continue to exist. Bilitis Foundation organized a special event in which LGBTI-friendly lawyers provided their interpretation and analysis of the Constitutional Court decision to trans and intersex people who are interested in legal gender recognition.
